Permission to Publish

In return for publication of the article _____

the undersigned author(s) (the “Authors”) (hereinafter, the “Article”), as of _____, 20____ (the “Effective Date”), hereby grant the American Speech-Language-Hearing Association (“ASHA”) the following rights in respect of the Article.

Authors hereby grant ASHA, for the full term of the copyright of the Article including all extensions, the worldwide right to: (i) reproduce, publish, distribute and sell the Article in all languages in ASHA’s publication *The ASHA Leader*, in ASHA’s online version of the publication, *The Leader Online*, and in subsequent collections of articles; and (ii) license others to reproduce, publish, distribute and sell the Article in all languages in other publications and formats. The license granted by Authors to ASHA shall be royalty free and non-exclusive except ASHA is hereby granted a right of first publication of the Article for a period of twelve (12) months following the Effective Date of this Agreement (the “Publication Period”). Authors shall not publish nor authorize the publication of the Article until the earlier of the expiration of the Publication Period or first publication of the Article by ASHA. Notwithstanding the foregoing, Authors retain the right at all times to use, adapt and distribute the Article, in whole or in part, for presentations in connection with classroom, academic, or professional activities.

Authors grant ASHA the right to edit the Article in ASHA’s reasonable discretion in order to meet ASHA’s publication standards. Authors further grant ASHA the right to use the Article in the creation of any derivative works.

Authors will at all times retain the copyright in the Article. Upon the earlier of ASHA’s publication of the Article, or upon the termination of the Publication Period, the Authors may publish the Article in any other publication or medium. Such publication must not include any art or photography supplied by ASHA in connection with ASHA’s publication of the Article.

Authors agree that in connection with any publication by them in accordance with this agreement, they shall cause to be included in such publication notice that the Article first appeared in a particular edition of *The ASHA Leader*. For example, an article by the author that was first published in the January 1, 2009, edition of *The ASHA Leader* should, when republished elsewhere by the author, carry with it the following notice: “Originally published in the January 1, 2009, edition of *The ASHA Leader*, available from www.asha.org.”

Authors acknowledge that subscribers to *The ASHA Leader* or users of the ASHA website will be permitted by ASHA to copy or download the Article. Authors agree to hold ASHA harmless, indemnify and defend ASHA against all damages and/or expenses, including reasonable attorneys’ fees, related to or resulting from any unauthorized or infringing use of the Article by such subscribers or users.

Authors, in signing below, represent and warrant that:

- The Article is their original work and has not been previously published in any other publication;
- The Authors are the sole authors of the Article and have full authority to enter into this agreement with ASHA; and
- The Article contains no material that violates any copyright, trademark, patent, proprietary, personal or statutory right of others.

Authors agree to hold harmless, indemnify and defend ASHA against all damages and/or expenses, including reasonable attorneys' fees, related to or resulting from a breach of the warranties above.

This agreement constitutes the entire understanding of the parties. No provision of the agreement shall be modified except by a written amendment signed by each of the parties.
