ASHA's Membership and Certification programs are based upon a calendar year. Applications received between September 1, 2011 and August 31, 2012 will be subject to rates listed below. Applications received after August 31, 2012 will be subject to dues and fee rates in effect at that time.

Please submit payment-in-full, U.S. currency only, with your application. The maintenance of your membership and/or certification, in addition to continuing professional development requirements (if applicable), is dependent upon payment of your annual dues and fees. Category of Application	Amount
Membership and Certification. For individuals who received their graduate degree prior to 2011 who are not eligible for the " Recent Graduate " category (see below).	\$511
NSSLHA Conversion. For members of NSSLHA who have held NSSLHA membership for two consecutive years at the time of graduation, and who are applying for ASHA membership and certification prior to September 1 of the calendar year following graduation.	\$286
Recent Graduate. For individuals applying for membership and certification within 12 months of their graduation date who are not eligible for the NSSLHA Conversion rate.	\$461
Certification without Membership. For individuals desiring to become certified without membership in the Association.	\$455
Dual Certification. For individuals already certified or in the process of certification in one area who wish to apply for certification in the other area. <u>Note:</u> Individuals who apply for certification in both areas at the same time pay fees for single area certification application only.	\$256
